Tree-of-Heaven Meets it Maker

Tree-of-Heaven (*Ailanthus altissima*) has been a well known invasive for decades (early New Jersey observations began in the 1950's). While it tends toward growing along heavily disturbed areas, it can be problematic along forest edges and clearings. We had a huge infestation growing on rocky slopes along with numerous rare species.

Question: How to safely unscramble the egg?

Answer: Stem injection with imazypyr!

The infestation consisted of hundreds of large trees and thousands of sprouts. It was a daunting task but we were able to secure grant funding to purchase two EZJect lances that use herbicide 'bullets' that made it possible to achieve virtually complete eradication. By treating each large tree (one bullet per 2 inches of diameter), the treatment not only eliminated the large trees, but also every attached sprout! Over the last two years, multiple rare species have responded positively!

Stewardship is always hard work and outcomes can be slow and/or uncertain, but it was an absolute pleasure to see rapid success this one time.

Tree-of-Heaven is extremely common and feeds the spread of Spotted Lanternfly (SLF). Anything we can do to reduce its abundance can also reduce SLF impacts. Stem injection is effective but initial equipment purchase can be pricey (about \$1,000 for injector and initial bullet supply). Basal bark applications can be effective too but we aren't sure if treating main stems will eliminate sprouts too - If you have experiences to share, please let us know.
