New Jersey Audubon Society: Invasive Plant Management on the Cape May Peninsula New Jersey Audubon is pleased to continue our partnership with the NJ Invasive Species Strike Team. This summer, we will continue to restore critical forest habitat on Cape Island



through invasive plant management. Cape Island is situated on the southernmost tip of Cape May peninsula, nestled between Delaware Bay and the Atlantic Ocean. Comprising of freshwater wetlands, scrub shrub habitat, maritime forest, grasslands, farmland, open water, and dune and coastal habitat, this is a critical stopover point for

migratory birds on the Atlantic flyway. New Jersey Audubon has been working to restore a 25-acre portion of forest habitat at Cape May Point State Park through non-native invasive plant management, thereby improving native plant biodiversity, and enhancing critical habitat for migratory birds and pollinators such as the monarch butterfly.

The initial focus of the restoration project was to preserve native trees in the overstory. Many of the trees were being overtaken by nonnative invasive vines such as English ivy, sweet autumn clematis, oriental bittersweet, and porcelain berry. Freeing the trees from this pressure ensures stable



habitat and food sources for migratory species as well as securing a native seed supply for the restoration area. This was paired with a management technique called forestry mowing which utilizes heavy equipment to mow down undesirable species in the understory. At the state park, this helped in suppressing bush honeysuckles, privet species, paper

mulberry, and multiflora rose. Since the mowing was conducted, follow up herbicide treatments of invasives in the understory have been conducted to maintain suppression.

With these management activities being implemented consistently since 2018, there has been a significant increase in native plant regeneration in the understory. In areas where the invasive management has been most effective, New Jersey Audubon has also incorporated supplemental plantings of woody species to provide more habitat diversity and resources for wildlife. New Jersey Audubon has expanded this work by taking on similar projects at nearby Lake Lily and Triangle Park and is excited to expand even further with the support and partnership of the NJ Invasive Species Strike Team.
