



ANNUAL FUNDRAISER: A great year behind us, please help us have another great year ahead!

It has been another successful year for the Strike Team! We received a new US Forest Service grant and are geared up for 3 more years of strategic control of invasive plants across New Jersey.

Project partners include:

We also partnered with multiple groups to treat invasives and develop plans for future efforts.

Collectively, the Strike Team and its partners eliminated over 1,800 populations of invasive species!

Outreach included professional and community conferences, and 18 presentations and field workshops reaching over 1,000 people.

- Professional Conference A fantastic day with nearly 100 attendees. We learned about aquatic invaders, climate change impacts, forest pests, and using eDNA for early detection.
- Community Conference South Mountain Conservancy's Rich Rockwell showed us their intensive control program, furthering support Volunteer Stewardship Teams.

Thanks to the ongoing financial support from generous private donors like you, the Strike Team is able to continue our critical mission of protecting our natural lands. Your donation will help us:

- Serve the conservation community and general public as a statewide clearinghouse on invasive species knowledge by allowing:
 - Engaged partners to stimulate passage of legislation to ban invasive plants
 - Improved web resources, phone app, and statewide database
 - Completed statewide Kudzu assessment, we confirmed 24 current populations and knocked off two of them already! We hope to raise funds to eradicate it from the state.
